From the President...

As 2006 draws to a close, the Board has prepared plans for 2007. As part of our planning we review activities for the prior year and anticipate expenses for the upcoming year to keep this community one of the best in Marietta. Your Board is responsible for developing and maintaining a budget each year for the expenses associated with operating our common property and sponsoring social activities for the entire neighborhood. Our assessment for 2007 will be \$338 (including full use of the swim and tennis facilities) and remains the lowest of comparable communities in our area. You should receive your assessment letter and Board of Director Ballot in mid-December. The following is the LCHA budget detail for 2007:


