Lee's Crossing Pool/Tennis Court Reminders



- Pools hours Monday – Saturday 11am – 9pm and Sunday Noon – 8pm
- Remember to walk, not run on the pool deck.
- During the safety breaks, anyone under 16 years of age must be completely out of the pool including the steps and away from the edges.
- The swim blocks may only be used by the swim team during meets and practices.
- Glass containers/bottles are not allowed in the pool or tennis court area.
- Only those who are playing tennis or pickle ball with the appropriate shoes and equipment are allowed on the courts.
