Voice of the Neighborhood:

Carly has voluntarily stepped out of the social committee lead role.

Secretary Report:

Matt B made a motion to approve the September minutes which had been previously circulated for edits or comments. Laura seconded and all approved.

Treasurer Report:

Angela Ford had circulated the financial reports up to October 12. YTD cash on hand is \$118255. Our loan balance is \$97619. Laura made the motion to approve the report and it was seconded by Dave Hettrich.

Swim & Tennis:

Pool:

Dave H reports he has a meeting with a supplier of the service about the installation of security cameras and other equipment in the RFP on Tuesday October 17. 2 vendors had responded adequately to the RFP and Dave believes he can work with this one company. He noted that they require that we do a lot of work to prepare for the installation. We will need to place plywood in the electric supply closet, buy new UPS for NVR and build out a closet in the hallway behind the refrigerator. They also suggest a new passage lock with a key for the door. A brief discussion was had about the year's service of the pool with Courtyard Pool management. The discussion was positive about their performance. Only on 2 occasions did a lifeguard show up late and this was much better than last year. Courtyard handled all issues we brought up very well and got good marks from Laura and others present.

Tennis/Pickleball:

Matt B noted that the courts are to be resurfaced at the end of this month or first of November. The vendors noted that with the grit coming up from the present surface, it will deteriorate fast and needs to be redone. The cracks will be dug into and repaired and then the new surface will be put down over these repairs. Pickleball lines may be placed on all four courts when the new surface is done. Pickleball continues to grow in the neighborhood.
