- 3. The committee must be informed of all materials used in your improvements in sufficient detail for proper review. Where appropriate, submit samples or color photos of the material (brick, slate, wrought iron, lighting standards, etc.) In its sole discretion, the Association may ask for

- 4. more information regarding your improvement during the review process. While waiting on a response from the owner the 30-day approval time frame will suspend and then resume with receipt of additional information.
- 5. Though neighbor approval is not required, depending on the improvement, the Association may solicit input from your neighbors regarding your submission and consider their input as part of the review process. It is prudent that you discuss proposed changes to your home with your surrounding neighbors.
- 6. PLEASE NOTE: The county may require approval of certain types of improvements. You may be required to get permits and other conditions may apply. The owner is solely responsible for fulfilling any municipal requirements.

The basis for this architectural requirement is your recorded covenants. Improvements made without architectural approval are subject to removal by the owner at the sole discretion of the Board of Directors or its designated agent.
