Congratulations to the newly elected Board members and thank you to all the residents who participated in the process. I would like to welcome our newest Board Member, Carl Trevathan. Carl and his family have resided in our neighborhood for 3 years. Angelia, his wife, is our wonderful newsletter editor.

But as we welcome one, we must say goodbye to another, Rob Ottley. Rob has served as Treasurer on the Board since 2003. During his tenure the Board made swim and tennis memberships available for all residents and expanded the Clubhouse.
