### **Happy March!**

Wow, is it just me or is 2023 moving fast for everyone? I'm using my space this month to highlight a few things that are important and recurring:

#### **Assessments**

Thank you to all who have paid to date. We are currently missing only a small percentage of payments. You may mail the payment to the Association with the provided envelope. You can also pay your assessment via Venmo at @LeesCrossing-HomesAssociation or https://venmo.com/LeesCrossing-HomesAssociation. Please keep in mind that a \$50.00 late fee went into effect on February 22<sup>nd</sup>. All fees must be paid in full to access any of the amenities (pool, tennis).

### **HOA Letters/Proof of Assessment**

If you need a letter from the Association for a sale or refinance of your home, or for any other reason, please be advised that the fee schedule is \$15 for a letter regarding refinancing, \$25 for closing letter information and \$40 for a 24-hour expedited letter. Please make payable to Lee's Crossing Homes Association and expect a 3-5 day turnaround. Please note that payment may be remitted via Venmo and must be received prior to issuance of the letter. Most lenders or closing attorneys wait until the last minute to alert you regarding the need for this documentation. You can eliminate stress by asking them upfront what they will require. Requests may be made by email to <a href="leescrossingmariettaga@gmail.com">leescrossingmariettaga@gmail.com</a>. Please note that we prefer the closing attorney request the closing letters and not the homeowner and realtor since each closing attorney has a different set of questions for the closing letter.

### **Trash and Recycle Changes**

The city of Marietta announced changes to our trash and recycle pickup. Trash collection will be reduced to one day a week. Recycle and brush pick up remain at one day a week. The new schedule goes into effect on April 17<sup>th</sup>. The city will deliver new carts to all residences over the next few weeks. These new carts are a bit larger than previous ones. You are still responsible for screening your trash can from the street view and may need to modify where/how you store it. 
