From the LCHA President...

As we enter this Thanksgiving season, we all have much for which to be thankful – a wonderful neighborhood, a vibrant city and a great country.

A few important items to note in this month's newsletter-

- Board of Directors Nominations Please find in this newsletter an announcement about nominations for Director and Treasurer positions up for re-election. Nominations are due by November 30th for inclusion in the ballot to be distributed in mid-December.
- Budget 2014 As part of our planning each year the Board reviews activities for the prior year and anticipates expenses for the upcoming year to keep this community one of the best in Marietta. Your Board is responsible for developing and maintaining a budget each year for the expenses associated with operating our common property and sponsoring social activities for the entire neighborhood. Our assessment for 2014 will remain unchanged at \$360 (including full use of the swim and tennis facilities) and remains the lowest of comparable communities in our area. The final 2014 budget will be approved at the December 12th Board meeting. See the attached proposed budget for 2014-2018.
- Remember to <u>vote</u> Tuesday, November 5th. Our election includes mayor, city council, school board and the Bond Referendum.
- Over the weekend of **November 15th 17th** our neighborhood will participate in a food drive for The Center for Family Resources' "**Thanks for Giving**" program. Food may be placed in the available boxes in the Hammock driveway at 1071 Chestnut Hill Circle. For more information see the flier included in the newsletter. - Each year during December we collect a "Dollar on Your Door" as a gift for the men who pick up garbage in the neighborhood. The neighborhood will sponsor the event again this year, but <u>we need your help</u>. Is there anyone interested in taking a leadership role for this activity? Nominations for the LCHA Board of Directors

The Board of Directors for the Lee's Crossing Homes Association consists of seven individuals elected by the members of the Association, six who serve staggered two-year terms and one who serves an annual term as Treasurer.

Next February, homeowners will elect three Directors for two-year terms, one Director for a one-year term (to fill an unexpired term) and the Treasurer for a one-year term, with all terms beginning March 1, 2014.

Individual resident homeowners who are in good standing with the Association and who consent to serve as a Director or Treasurer may have their names submitted to the nominating committee for inclusion on the ballot. Nominees must be current on all assessments, must pay their 2014 assessments by the close of balloting on February 21, 2014 and must not be subject to any unsatisfied Association fines or liens.

The nominating committee consists of Walt Walker and Joe Fenton. Nominations must be in writing and must be received by the committee on or before November 30th. 
