**Proposed 2021 Budget** - In this month's newsletter, you'll see our proposed 5 year budget. We are proposing an increase to the assessment for 2021 to \$395 (which remains the lowest fees for all comparable swim & tennis neighborhoods in the City). The budget numbers include opening the pool for the summer on the afternoon of the last day of school, presumably May 26, and operating weekday afternoons after the schools go back in session in August. Various expenditures may change due to the pandemic (as they did for 2020), including our ability to open the clubhouse for rentals and to host large gatherings such as swim meets and various social events. #### Nominations for the Board of Directors

The Board of Directors for the Lee's Crossing Homes Association consists of seven individuals elected by the members of the Association, six who serve staggered two-year terms and one who serves an annual term as Treasurer. All positions are unpaid.

Next February, homeowners will elect three Directors for two year terms and the Treasurer for a one year term, with all terms beginning March 1, 2021. There will be three Director positions on the ballot (two are currently held by Joe Fenton and Walt Walker and one is vacant), and the current Treasurer is Angela Ford.

Individual resident homeowners (or designees in the case where the homeownership is in a trust, LLC or corporation) who are in good standing with the Association and who consent to serve as a Director or Treasurer may have their names submitted to the nominating committee for inclusion on the ballot. Nominees must be current on all assessments, must pay their 2021 assessments by the close of balloting on February 21, 2021 and must not be subject to any unsatisfied Association fines or liens.

Nominations must be in writing and must be received on or before November 30<sup>th</sup>. Nominations must be mailed to the attention of the nominating committee at Lee's Crossing, P.O. The nominating committee for this year includes John Branham, Chad Ellis and Phil Karp.
