#### Nominations for the Board of Directors

The Board of Directors for the Lee's Crossing Homes Association consists of seven individuals elected by the members of the Association, six who serve staggered two-year terms and one who serves an annual term as Treasurer. All positions are unpaid. Next February, homeowners will elect three Directors for two-year terms and the Treasurer for a one-year term, with all terms beginning on or about March 1, 2023. There will be three Director positions on the ballot (these are currently held by Laura Fenton, David Hettrich, and Matt Burnham), and the current Treasurer is Angela Ford. Individual homeowners (or designees in the case where the homeownership is in a trust, LLC or corporation) who are in good standing with the Association and who consent to serve as a Director or Treasurer may have their names submitted to the nominating committee for inclusion on the ballot. Nominees must be current on all assessments, must pay their 2023 assessments by the close of balloting on February 21, 2023 and must not be subject to any unsatisfied Association fines or liens. Nominations must be in writing and must be received on or before **December 7**<sup>th</sup>.

Nominations must be mailed to the attention of the nominating committee at Lee's Crossing, P.O. Box 1013, Marietta, GA 30061 or emailed to leescrossingmariettaga@gmail.com. The nominating committee for this year includes Directors Phil Karp, Leslie Brown and Robert Meaders.
